RAISING FUNDING TO
SUPPORT STEWARDSHIP OF
OUR NEW HAMPSHIRE TRAILS

The Purpose is to raise collaborative funds that can be used by recreational organizations, Federal or State Park Agencies and Conservation Agencies to support trail improvements and maintenance and the acquisition of trails and trail heads for equine use.

For years, local individuals, recreational organizations and trail riding clubs have been the backbone of the effort to raise funds that are an essential part of the trail stewardship equation. The principal method of fund raising for equine users has been the benefit trail ride. These events often have a limited monetary return. This new opportunity adds to and does not replace the efforts done by a small minority of the equine community. We have a larger, under-utilized, community that can be involved to SUPPORT WHERE THE HOOVES GO.

Support donations from the larger equine community and the attendant support of businesses will help to establish relationships with other trail user organizations and with private and public land managers.

This will allow NHC to award monetary gifts and/or provide matching funds to sponsor an organizations project thus enabling efforts to increase the scope and timeliness of trail work that benefits our equine community.

Fund raising effort

To accomplish this, we are reaching out to the greater equine community in New Hampshire for donations to the fund.

Who will our target sponsors be?

- Individuals from the equine community
- Equine Clubs/Organizations
- Local Businesses related to the equine industry

NHHC members and affiliate members are our primary help with soliciting funds via Facebook posts and other fund raising methods. These members can also nominate a recipient to be considered.

Award size

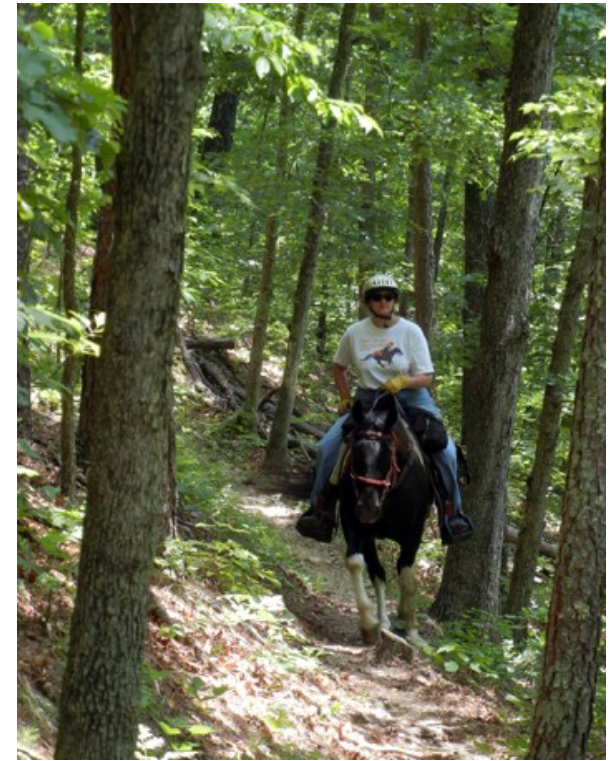
The size of the proposed awards will be governed by the success of our fund raising project. With the aim of raising \$1,000 a year we are anticipating being able to grant Approximately \$500 per award.

- hiring student conservation groups, trail designer, etc.
